AGREEMENT

The Vendor agrees to pay \$_____ to participate as a vendor in this event.

THE EVENT

The Event is hosted by WDIF-LP 97.5 FM and takes place on Saturday, Novemeber 24th, 2018 from 10:00am to 4:00pm at The Marion Centre Mall, which is located at 1509 Marion-Waldo Road in Marion, Ohio. Set up for the event will begin as early as 8:00am with Opening Remarks at 10:30am. The event will be inside and will be held rain or shine. Marion Makes Music, Inc. will not take any percentage of the vendor sales for the day of the event.

AMENITIES

For food-serving vendors and other attractions as arranged, Marion Makes Music will provide electrical hookup. If you require power other than standard 110v, please let us know so that arrangements can be made. Water service is not currently available. For "craft" and non-food vendors, you will be assigned a ten-foot by ten-foot space in the craft booth section where you can setup any display you like. We currently do not have electric available for the craft vendor area at this time.

YOUR LIABILITY

The Vendor is required to carry their own applicable licenses and be current on any/all health and safety inspections. The Vendor shall indemnify, defend and hold harmless Marion Makes Music, Inc., its representatives and event sponsors from and against any and all costs, expenses or liability arising from or related to all claims made or threatened by any third party towards The Vendor, and any/all losses, expenses, damages, costs and liabilities, including reasonable attorney fees and expenses incurred in investigation or defense (damages) to the extent such damages arise from negligence on the part of The Vendor and/or from the violation of permits, inspections, etc.

OUR LIABILITY

Marion Makes Music, Inc. shall indemnify, defend and hold harmless The Vendor and their representatives from and against any and all costs, expenses or liability arising from or related to all claims made or threatened by any third party towards Marion Makes Music, Inc. and its representatives, and all related losses, expenses, damages, costs and liabilities, including reasonable fees and expenses incurred in investigation or defense (damages) to the extent such damages arise from issues not involving The Vendor.
